



# Iowa Legislative Report

## Iowa State Snowmobile Association

The third week of the session passed quickly this week. It is clear that legislators are intent on making this a shorter session than last year. One of the measures considered was a resolution that officially moves the funnel deadline up a week. That means that bills will have to be out of committee in the chamber of origin by the end of the seventh week.

Legislators have until March 16<sup>th</sup> to file their nomination papers to run for reelection. Reapportionment from the 2010 census has thrown some incumbents in the same district and has changed the makeup of other districts. The result is that we are seeing some veteran legislators deciding not to run and some ex legislators announcing their intention to seek public office again. The result will be that we will see a lot of new faces next year. The retirements also mean that some of the legislators want to get out of session as soon as possible.

**The big news for snowmobilers concerns Senate Study Bill 3050. The bill is a DNR proposal to update the ATV and Snowmobile Chapters of the Code. We offered the subcommittee an amendment that would require residents and nonresidents riding on public land, ice or trails to get a trail permit at the cost of \$15. This would provide needed funds for the trail program and only place the fee on those sledders that are using the public trails or land. The subcommittee accepted the amendment and it goes to the full committee for their consideration. A special thanks to the Subcommittee Chair, Senator Schoenjahn (D-Arlington) and Subcommittee members Senators Ragan (D-Mason City) and Hahn (R-Muscatine). We need you to communicate your support to the members of the subcommittee and the full Senate Natural Resources Committee.**

Another issue of special importance is the motor fuel tax increase initiative. There have been conflicting statements by key players on the merits of the increase. The DOT issued a report that cited potential savings of \$50 million in expenditures that could be used for road improvements. The Transportation Chairs, Senator Reilly and Representative Tjepkes, indicated that they intended to move bills forward that would increase the tax. The Governor has indicated that he won't necessarily veto an increase, but he has not been vocal in support of the measure. The Speaker of the House indicated on Thursday that the House would be focusing on cost savings contained in the DOT report. It is unclear whether the bill will come up for a vote, especially in light of the position of a major Taxpayers Group (ITR) in opposition to an increase in the fuel tax. **Regardless of when this issue is debated, we need to be vocal to legislators that we want our fair share of the fuel tax used on trails.**
